On August 2, 2005 the Lake Eunice Township Board held their monthly meeting at the Lake Eunice Townhall. Chairman M Reep called the meeting to order at 7:30 pm. All board members were present. The minutes from July 5th were approved as written by a motion from L Kohler, 2nd by J Maki and it carried. A motion from L Kohler, 2nd by J Maki, approved the treasurer's report and it carried.

New Business:

E Big Cormorant Lake Rd resident, Lu Anderson was present regarding her drainage issue. Chris Leach was unable to attend so the Andersons were going to go talk to him at his house to get some answers on a solution.

Dennis and Patricia Gilbertson, Gail Gaebe and Gary Marvin were present regarding the request of the removal of their trees in the right-of-way. They stated we were inconsistent with that request because of other trees in the ditches on that road. They were informed that we can only request trees be moved under a certain diameter and that it is being done to prevent future problems when the trees are large.

Erlin and DeVaughn Kolke of Tanglewood were present to see if any solution to his drainage problem has been found. The twp had this road lasered at that location to see if clearing out the ditch would be the solution, but the results show it won't solve the drainage issue.

Jason Benson was present with surveyor Scott Walz to propose his future development. The board agreed to the proposal of approximately 2 ½ acre lots on a cul-de-sac road with a 75-foot top and leaving a dedicated area for a future through road.

Lanny Stockert, Chris and Belinda Reep, Curt Olson, Adrian Flicsek, along with a letter from Bill and Sharon Lipp requesting we pave either Deroxe Rd or Erickson Rd (westbound road) soon and if we are choosing with arterial road to pave first that we do one of those first as a benefit to those coming from the Maud Lake area and heading towards Fargo. These roads will need some work first and one of those roads are going to be proposed as being paved.

Scott Hendricks will use his blade and create a needed ditch on Sportsman Rd.

Charles Chadbourne was present to discuss subgrade prep work to be done on St Mary's of the Lakes Rd to be done by Scott Hendricks before the proposed paving can be done.

A no-wake ordinance is in place on Big Cormorant Lake.

Jay Carlson was present with a proposal to change his road on Tanglewood with costs being paid by owner. L Kohler made a motion to accept this proposal, 2nd by J Maki and it carried.

Motion by L Kohler to adjourn, 2nd by J Maki, motion carried 9:25pm.
