The Lake Eunice Township board held their monthly meeting at the town hall on June 14, 2011 at 7pm. All members were present. The minutes from May 10, 2011 were approved as written by a motion from L Kohler, 2nd by D Opsahl and it carried. Claims were reviewed for payment and transfer of adequate funds to cover payment of claims and payroll was approved as well as the treasurer's report which was reviewed and approved as written by a motion from L Stockert, 2nd by G Johnson and it carried.

The discussion and presentation of Tanglewood Rd improvement options was held. The 3 options include: (1) Repair soft spots by digging down 12", add fabric, cover with class 5 gravel and cover with crushed asphalt at no cost to the residents; (2) Option one plus recycle asphalt, fabric, and 3" of class 5 gravel on the entire road at a cost of approx \$79,000; (3) Option one and two plus Base One, Otto Seal, Chip Seal and build up ramps at a cost of approx \$209,350.

Dave Dorff was present with the petition for Pearl Circle subordinate service district to Otta Seal and chip seal the road. D Opsahl made a motion to accept the petition, 2nd by L Stockert and it carried. A public hearing will be held at the July board meeting.

Richard Varberg was present to request a property line waiver to run the septic up to the right of way on Mike Vandal property. A motion to accept was made by L Stockert, 2nd by G Johnson and it carried.

Rick Renner was present to request a property line waiver for a holding tank to run up to the right of way on Brad Henrickson property. L Stockert made a motion to approve, 2nd by G Johnson and it carried.

Darcy Savig, Audubon Fire Chief, was present to discuss their proposals for a new fire hall. The next meeting to discuss this project will be held at 7pm on Aug 11, 2011 at the Audubon Fire Department.

Board discussed current road projects and repairs.

A motion was made to adjourn at 8:24 pm by L Stockert, 2nd by D Opsahl and it carried.
